He has led numerous projects for streetcar development including new expansions for the Portland system, vehicle manufacturing, feasibility for other cities, and operational plans for many other cities, including streetcar projects in Los Angeles, Ft. Worth, San Antonio, Detroit, Seattle, Boise, and the District of Columbia. He was also the lead consultant for the City of Portland in developing the Central City Transportation Management Plan.

Rick has had a wide variety of experiences and expertise in the urban transportation field. His initial education was as a Research Economist for General Motors Corporation where he explored travel demand theory and travel behavior. He published over 25 technical journal articles relating travel behavior modeling and projections. Rick moved to Portland, Oregon, his original home, and was elected to the Oregon House of Representatives in 1975 serving on the Ways and Means Committee for two terms and Chairing the Transportation Subcommittee. In 1978, he was elected as Metro's first Executive Officer, a post he held until 1986. Rick was a key political leader in supporting the first light rail in Portland which has proven to be very successful.
